Easing of Restrictions

The government has updated the <u>Safe Use of Places of Worship</u> to include details of how restrictions will be lifted for churches in England. The key changes involve:



Step 3 - 17 May 2021 (link to poster)

- Most other significant life events can resume, limited to no more than 30 people. This will include events such as private baptisms, and naming ceremonies. Limits at weddings, wedding receptions, wakes and other commemorative events will be increased to 30 people.
- Funerals will have no legal cap on the number of people who can attend.


 The number of attendees will be determined by how many people the venue can safely accommodate with social distancing measures in place.
- Outdoors most legal restrictions on meeting others will be lifted although gatherings of over 30 people will remain illegal unless otherwise exempt.
- Support groups and parent and child group gathering limits will increase to 30 people (not including under 5s).

COVID Secure rules, including social distancing requirements, continue to apply in the workplace, and in businesses and public venues. Further information can be found on <u>Coronavirus Guidance for Property</u>. Please note that this is only for England.
