

CANDIDATING FOR ORDAINED MINISTRY

PORTFOLIO GUIDANCE (DOV2)

C.7

The portfolio is your opportunity to present yourself to the Church. There is flexibility in the presentation methods to enable you to tell your own personal story. It will help you in your process of discernment and offer evidence of how you are meeting the criteria for candidates for ordained ministry. It is intended to be a significant piece of work which aims to give the Church a picture of your exploration of your call to ministry.

Practical elements	
Support	While candidates take responsibility for producing their own portfolios, there are various places where they can find support
	Candidates can ask anyone to help them with, for example, organising their material, deciding on the format to use and proof reading, while always remembering that the portfolio must be their own work. This support may come from the accompanist, their local minister or from a trusted friend.
	The Learning Network will support you to make the most of your portfolio. They run a two hour online session to assist you. From that session you will come away with a clear sense of 'what is expected in the portfolio', and 'how to create the content'. You can attend either the session in June 2024 or the same session repeated in September 2024. Format and methods	Different people find it more natural to present ideas and reflections in different ways. Therefore there are a variety of ways to present the different elements of the portfolio. Please do follow the format specified for each element.
	Where 'creative methods' are specified, here are some examples: <ul style="list-style-type: none">• Mind map• Collage• Art work• Poem• Video of a powerpoint presentation• Dramatic story-telling on video• Diagram• Video of drama or dance• Photo of a 3D sculpture• Song If you would like to use a different method, you are welcome to do so as long as it can be easily shared electronically and you feel able to express yourself in that media.

	<p>'Creative <u>visual</u> methods' means things that can be comprehended by readers from a piece of paper (i.e. not using a video or audio method).</p> <p>It must be able to be submitted electronically. So if it involves a large art work (for example), you will need to submit a photograph of the art work rather than the original art work.</p>
Adjustments	<p>If you have a learning need or disability that makes this task difficult, and you need any adjustments, please explain these adjustments at an early stage to the candidates' office.</p> <p>The portfolio readers will adjust their methods as appropriate while ensuring fairness to all candidates. It is the candidate's responsibility to make such adjustments clear at an early stage.</p>
Length	<p>You will not be penalised for exceeding a word count or particular length. However portfolios do need to be sufficiently substantial to present the candidate's thinking clearly, and concise enough to be manageable.</p> <p>There are guideline lengths given for each section of the portfolio. These are the suggested maximum lengths but it is wise to produce your material close to that maximum length in order to make the most of this opportunity to present yourself and your reflections. Please be aware that readers cannot guarantee to read material that greatly exceeds the suggested maximum lengths.</p>
Structure	<p>Present your material in an organised way and ensure that you have proof-read the written elements and checked the other elements for any errors.</p> <p>It is essential that you include the title page at the start of your portfolio, using the structure outlined below</p> <p>Those reading/hearing/watching it need to be able to navigate through the material. Therefore please clearly label each section with the letters in the guidance below. Please also consider using clear headings and subheadings and page numbers.</p>
Voice	<p>The portfolio must be your material alone and offered in your authentic voice.</p> <p>You are welcome to include quotations but please ensure that these are clearly referenced. Do not be tempted to use words written or spoken by someone else as if they are your own.</p> <p>You may include creative work produced by someone else, but please ensure that you make this clear and acknowledge the source. Please also state why you have included it.</p>
Referencing	<p>Please use a clear and consistent way of referencing books and articles. For example: Surname, first name or initial/s, <i>title of book</i>, place of publication: publisher, date of publication. Also please be clear when referencing other material: For example. when referring to an art work: Surname of the artist, first name or initial(s), <i>title of the artwork</i>, date of its creation, the medium, where and when you saw it, name of the exhibition. When referring to a performance: Name of the performers or group, <i>title of the piece</i>, where and when you saw it, the medium (eg theatre, music, dance)</p> <p>Always indicate the source of quotations, giving page numbers. If referring to a website, give the date on which the website was visited because material on the web changes over time. Also give the weblink.</p>



	If you use footnotes please only use them to add references, not for additional material.
Standard	The academic standard expected is HE Level 4, which is the same as for <i>Worship Leading and Preaching</i>
Submission	Please ensure that your portfolio is submitted before the deadline date. This is really important. Even if you usually work right up to deadlines, you are encouraged to start working on it as early as you can. This will give you time to reflect on it and make changes as you go along. Also it is important to build in some time to make sure you can navigate the technological aspects.
	If it is established to the satisfaction of the responsible Connexional Team officer that your submission of the portfolio is likely to be delayed due to illness or other exceptional valid cause, identified on production of acceptable evidence, the officer will advise you on what course of action to take.
	Please submit written material as a pdf file so that your formatting cannot be changed.
	You will be given a link to a Sharepoint folder specifically for your portfolio. Please upload your portfolio there in seven separate folders named: 'John Smith Portfolio Title Page', 'John Smith Portfolio Section A', 'John Smith Portfolio Section B', and so on. There can be challenges in uploading documents onto sharepoint and deleting or renaming them once they are there so please make sure you have checked that you can do this in advance. Please check in particular that any video or audio files you upload can be easily opened and seen. Perhaps ask a friend to check these from another computer. Please check the sound quality in particular. For information about using sharepoint, please see this link: What is SharePoint? - Microsoft Support
Readers	Each portfolio will be 'read' by a group of people with experience in discernment and assessment.
	They will not give a grade for your portfolio but will produce a guidance report with suggestions. This report will be seen by the DOV2 Connexional committee. The use of the word 'reader' is intended to include all ways in which the group will encounter your portfolio (which clearly could include hearing and watching too).
