## Love Your Burial Ground Week

Caring for God's Acre annual [Love Your Burial Ground and Churches Count on Nature](#) week has been set for **8th - 16th June 2024** and there is a focus on the brilliant wildlife to be found in churchyards and chapel yards. It is a joint initiative promoted by Caring for God's Acre, the Church of England, the Church in Wales and A Rocha UK.

Over 27,000 wildlife records have been submitted during this dedicated week over the past two years, and many recorders are continuing to submit records through the burial grounds project on [iNaturalist UK](#).

## The Story Behind the Restoration of the Spire

It was a great relief to know that while storm Babet did its worst, the Spire and roof at [St Andrew's church](#) in Sheffield were secure. It is less than a year since we started to raise funds to undertake the restoration of the Spire, having been told by the architect that we should complete this during the summer of 2023, as it was probable it would not survive another winter.

The Spire Restoration Group worked hard to raise funds and manage the project. We investigated the possibility of removing the spire - after all it is an aesthetic architectural feature, without function as a bell tower or ventilator - but we were advised that as an important aspect of the Grade II listing and would have to be replaced (which would have cost more than the £135k required for restoration). The National Churches Trust will work with partners to deliver a grants programme for maintenance works, promote sustainability in church buildings and provide a range of support to help churches open to visitors and tourists. This will ensure even more people can enjoy the stunning heritage that these churches across Scotland, Wales/Cymru and North-West England have to offer.

## Guidance on Special Historic Interest

Historic England has published guidance [Understanding Special Historic Interest in Listing](#) to help people better understand special historic interest, one of the two main criteria used to decide whether a building can be listed or not.

Special historic interest is about the connection between the building and the people who use or have used it, the things that happen or have happened there, the ideas that were developed there or the role that the building played in the nation's history. HE's guidance provides advice on how they might assess a building's special historic interest, as well as examples to illustrate the historic interest of different buildings.

Such examples include a converted Wesleyan Methodist Church (now the St Mary Protectress Ukrainian Orthodox Church). It also explains HE's approach to addressing difficult or uncomfortable heritage. [Click here to read more.](#)

## Update from HMRC on VAT associated with Burials

HMRC has updated [Burial, cremation and commemoration of the dead \(VAT Notice 701/32\)](#). It explains the VAT liability of funeral services, burials and cremations, goods and services connected with the commemoration of dead people, other goods and services connected with organising funerals, and other activities relating to the disposal of the remains of the dead, including transport of the deceased. In general, the following services are exempt from VAT:

- the disposal of the remains of a deceased person;
- the making of arrangements for, or in connection with, the disposal of the remains of the deceased; and
- the services of one undertaker to another in connection with a specific funeral of the deceased.



Specifically in relation to places of worship:

- fees payable to churches for ministers' services are outside the scope of VAT;
- orders of service for use in funeral commemorative services are zero-rated (read Zero rating of books and other forms of printed matter (VAT Notice 701/10))
- burial (including reburial), cremation and interment of ashes are exempt from VAT, as is the digging, preparation and refilling of a grave.

If the following details could be provided to enable them to add your premises to the Churches contract:

- The full name and address with postcode for the invoice
- The name and telephone number of the contact to arrange access to site
- The name and address of the site that is to be serviced
- The due month in which the service is required

On receipt of this correspondence they will arrange to visit your premises. Subsequent to each annual service carried out, any recommendations for replacement or additional extinguishers will be forwarded to you for your approval.



## Workplace health, safety and welfare: legal requirements

## Portable Appliance Testing - busting the myths

Portable appliance testing (PAT) is the examination of electrical appliances and equipment to ensure they are safe to use.

There are many myths about PAT but you can use [HSE's frequently asked questions](#) to find the key facts about the inspection and testing of portable electrical equipment.



As Christians we are called to care for God's creation and to work for justice in the world. We are currently living in a climate emergency which threatens much of the life on earth and disproportionately affects those people who did least to cause it.

The Methodist Church in Britain has set a target of net zero by 2030. This will require action in a number of different areas and contexts, but crucial to achieving this aim will be ensuring that the energy we use is green, renewable energy. Moving to using green electricity not only ensures that the energy we use does as little as possible to contribute to the climate emergency but also allows us to demonstrate collectively that we, as a Church, want to see the building of greater capacity for renewable energy.

Managing Trustees could also contact other churches in their circuit and/or district to see if they might be interested, as sometimes brokers can offer deals for a cluster of churches.
