Energy Bill Support

The government has published further details on the six-month scheme for businesses and other non-domestic energy users (including charities and public sector organisations like schools) will be offered support as is being provided for consumers.



It will apply to energy usage from 1 October 2022 to 31 March 2023, running for an initial six-month period for all non-domestic energy users. The savings will be first seen in October bills, which are typically received in November. Customers do not need to take action or apply to the scheme to access the support. Support (in the form of a p/kWh discount) will automatically be applied to bills. The level of price reduction for each business will vary depending on their contract type and circumstances

After this initial six-month scheme, the Government will provide ongoing focused support for vulnerable industries. There will be a review in three months' time to consider where this should be targeted to make sure those most in need get support. Click here to read more.

Insurance and Listed Buildings

This is a reminder for those custodians who make an insurance claim for works to listed buildings. It is likely that your insurance company has a list of contractors who undertake repair works as part of any claim. This list often includes contractors and general builders who undertake claims works on domestic and commercial properties.



In the case of churches which are listed buildings it maybe that these contractors do not have sufficient experience or skill to undertake the specialist and high quality works required for our more historic buildings. In such circumstances your insurer may suggest the church ask their architect or surveyor who does the Quinquennial Inspection to draw up the specification of works (this will be more detailed than a schedule of works a general building contractor will produce) and then employ a contractor with the necessary skills to carry out the work. The associated fees and works should be covered by the insurance claim.

Any trustee who finds themselves making a claim for works to a listed building should clarify the above with their insurance company and any resulting specification should be submitted to and approved in writing by the Connexional Conservation Officer before the works commence.

A Commitment to Move the Work of God Forward at this Time, in this Place

Trinity Methodist Church is small village chapel in Broad Oak, East Sussex. The church is a listed building and has a graveyard with about 500 plots that are still in used for interment of ashes. The church was looking 'weary worn and sad' - a shabby exterior with a collapsing notice board, a dreary vestibule, a shabby, poorly lit church with hard pews, crumbling rear extensions, lack of disabled facilities, only cold water,



etc. It did not give the feeling of a caring, lively community.

Asbestos Inspections

Did you know that if a building has asbestos, it should be checked regularly - every 6 months to 1 year depending on the type and location of the asbestos?



The initial survey should be undertaken by a specialist who will prepare a formal report which should be kept in the church log book. It is then the Church Council as Managing Trustees who have the responsibility as duty holders to manage the ongoing risk by having regular inspections, which can range from 6 months to 1 year depending on the type and location. The first stage is to prepare a risk assessment to determine whether asbestos is present in your buildings. If it is, there are only two options:

- High risk the asbestos must be removed
- Low risk it can be sealed and left in position, together with warning notices and possibly minor repair.

If asbestos is found, the duty holders must:

- Take reasonable steps to find out if there are materials containing asbestos in non-domestic premises, and if so, the scale of the problem, where it is and what condition it is in;
- Presume materials contain asbestos unless there is strong evidence that they do not;
- Make, and keep up to date, a record of the location and condition of the asbestos containing materials (ACMs) or materials which are presumed to contain asbestos:
- Assess the risk of anyone being exposed to fibres from the ACMs;
- Prepare a plan that sets out in detail how the risks from these materials will be managed;
- Take the necessary steps to put the plan into action;
- Periodically review and monitor the plan as well as check the asbestos, ensuring the arrangements and the condition of asbestos remains safe, relevant and up to date;
- Provide information on the location and condition of the materials to anyone who is liable to work on or disturb them.

Grant Opportunities

Grants for Churches for the Conservation of Decorative Features and Monuments (UK)

Grants of between £500 and £5,000 are available to churches, chapels and other places of worship built before 1896 to carry out small programmes of conservation work to decorative features and monuments. All work funded must be directed by a



professional architect or established conservator and completed according to the principles of the Society for the Protection of Ancient Buildings (SPAB). The funding is being made available through the William and Jane Morris Fund. Applications can be submitted at any time however the **next closing date for applications is the 31st March 2023.** Click here to read more.

Applications Re-Open for the Co-op Community Fridge Fund (UK)

The Hubbub Foundation, in partnership with the Co-op, has re-opened the Co-op Community Fridge Fund to build on their existing network of Community Fridges around the UK. Grants of £4,000 are available to support an additional one hundred not-for-profit organisations across the UK to establish new Community Fridge projects and help redistribute surplus fresh food within deprived communities. Donations are provided by local food businesses, producers, households and gardens, saving food from going to waste and bringing people together. Hubbub will also provide support, guidance and resources to help organisations establish their Community Fridge. **The closing date for applications is the 30th October 2022.**

Funding for Churches Supporting Refugees Arriving from Ukraine & Afghanistan (England)

Grants of up to £5,000 are available to Christian churches and registered Christian charities offering activities and services to welcome and support refugees arriving in England from Ukraine and Afghanistan. This could include services and activities such as supplying accommodation, clothing, food, mobile phones, and baby care items; befriending support; English language classes; baby and toddler groups; welcome parties; drop-in sessions; and expenses for volunteers or facilities. The funding is made available by the Church Urban Fund in partnership with the Benefact Trust, through the Refugee Support Small Grants Programme. This is a rolling fund and applications will remain open until the 9th December 2022, but may close earlier if all funding is allocated before this date. Click here to find out more.

Funding for Charity Building Projects (London)

Registered charities and exempt bodies in London undertaking building projects of less than £200,000 can apply for grants of between £5,000 and £10,000. The building work can include general refurbishments or a specific scheme; repairs; creating disabled access; or fulfilling of Health and Safety requirements or fire protection. The funding is being provided through the Rose Foundation and **the**

next closing date for applications is the 31st March 2023. Click here to find out more.

£25,000 Grant for Christian Reflection on Independence (Scotland)

Christian charities and educational establishments are invited to bid for a one-off grant of £25,000 to organise events reflecting on Scotland's constitutional future. The funding is made available by the Paristamen Charity through their Blue Sky Grant: Christian Reflection on Scotland's Constitutional Future, to enable a charity with specific experience in the field of Christian debate and social action to coordinate events with the support of local churches and Christian groups across Scotland in the run-up to the proposed independence referendum in October 2023. The project should enable both sides of the independence debate to be heard in a context of Christian reflection. Charities interested in submitting proposals are asked to contact Paristamen as soon as possible for an informal discussion, with **proposals due by the 17th October 2022.**

Energy Cost Survey

Trevor Cooper, Chair, and Becky Payne, Development Director, of the <u>Historic Religious Buildings Alliance</u> (HRBA) are seeking hard evidence about the likely extra energy costs that will be incurred by historic churches and other places of worship this winter for its parent organisation, the Heritage Alliance, to present to Government, as follows:



ENERGY COSTS THIS WINTER

- We would like to know your energy costs last winter and your best estimate
 of costs this coming winter. These are total costs, not price per unit of
 energy.
- 2. We would also like to know if at present you foresee or are considering any reduction in your activities because of increased bills, and any details you can give us.
- 3. We need to know on whose behalf you are responding, though all information will be anonymised. That simple information will be very useful in making a case. However, if possible . . .

- 4. Please tell anything else you think it would be useful for us to know to present a case to government. Here are some possibilities, but none of this is essential:
- whether your building is a cathedral, or in any other way of unusual size or complexity
- roughly how many people are financial supporters of the building (alternatively, typical congregational attendance)
- some idea of the size of your annual income and of your annual surplus (if any)
- whether you would describe the location of your building as village, small town, suburbs, urban, city centre - or any other descriptor of location
- if your building is the only place of worship in the community (this will tend to be in villages and some small towns), the approximate number of people living in the community
- anything you might know about local levels of deprivation
- anything else you want to tell us.

Annual Charity Return (Scotland)

Every registered charity in Scotland is required to submit an online annual return to OSCR of its accounts, trustees' annual report and external scrutiny report. The upgraded version of OSCR Online went live on 25 July 2022, and every person listed with OSCR as a principal contact for a charity was sent an e-mail with



new login instructions. People who are the principal contact for multiple charities were also sent a separate e-mail listing all the charities with which they are associated.

- If you are a principal contact and have not received for these invitations, please check your e-mail inbox and junk e-mail folders.
- If you are a principal contact of a charity and did not receive an invitation to the new system by 31 July 2022, please e-mail info@oscr.org.uk.

When you log in OSCR Online after the upgrade, you will be asked for the Scottish charity number for the charity on whose behalf you want to submit information. If you do not know this number, you can find it on the Scottish Charity Register (it begins SC0 [ZERO]). Click here for further details.
