Covid-19 Guidance from TMCP

TMCP would like to draw Managing Trustees attention to the new guidance available on <u>residential conveyancing transactions</u> during the COVID-19 crisis. The Government has issued guidance for the public and industry in relation to home buying and this has prompted the Law Society to follow suit and provide guidance for Solicitors.



Guidance for dealing with the COVID-19 pandemic is evolving on an almost daily basis. The effect of COVID-19 is wide reaching and may affect ongoing works for

some time to come, including but not limited to those logged as property projects on the property Consents Website for some time to come. To assist Managing Trustees, TMCP have produced a guidance note COVID-19 and its effect upon Building Contracts and works to Methodist Churches.

Additionally, there are updates to the list of <u>Frequently Asked Questions</u> about residential & non-residential leases during the Covid-19 pandemic.

The Community Fund is prioritising projects and organisations supporting communities through the COVID-19 pandemic. Priority will be given to projects that focus on:



- organisations supporting people who are at high risk from COVID-19
- organisations supporting communities most likely to face increased demand and challenges as a direct result of COVID-19
- organisations which connect communities and support communities to work together to respond to COVID-19

Heritage Alliance (of which the Methodist Church is a member) has produced <u>COVID-19 Guidance</u> for the Heritage Sector. This includes a <u>Covid 19 Guidance</u> <u>Hub</u> and <u>Covid-19 Funding Hub</u> which outlines the advice and sources of national and regional funding to help mitigate the effects of the pandemic.



The Arts Council has announced the availability of grants up to the value of £35k to help with urgent operational costs following loss of income. Projects must address one or more of the three strategic priorities:



- bringing people together and build strong relationships in and across communities
- improving the places and spaces that matter to communities
- helping more people to reach their potential, by supporting them at the earliest possible stage.

Heritage Emergency Fund is short-term funding to support the immediate actions needed to stabilise operations and manage unforeseen risks. The deadline for applications is on **Tuesday, 30 June 2020**.
