As well, there are new FAQ's on the Methodist Church Official Guidance including:



Covid-19 Guidance from TMCP

Covid-19 and the 'lockdown' have thrown up a number of potential problems for tenants who are experiencing a reduction in their income. TMCP has listened to the concerns raised with Managing Trustees by their tenants and are sympathetic with a desire to help those in need. Therefore, guidance has been produced on <u>Payment of rent: Concerns raised by tenants during Covid-19 pandemic.</u>





Additionally, there are updates to the list of Frequently Asked Questions about residential & non-residential leases during the Covid-19 pandemic.

Emergency Heritage Funding

The Heritage Emergency Fund is short-term funding to support the immediate actions needed to stabilise operations and manage unforeseen risks. You can apply to us for a grant between £3,000 and £50,000 to

cover unavoidable costs you will otherwise be unable to meet for up to four months. You should only apply to us for essential costs and partnership funding is not required. The deadline for applications is on **Tuesday**, **30 June 2020**.

Historic England's Covid-19 Emergency Response

Fund provides grants to help organisations, voluntary groups and self-employed contractors

survive the immediate challenges and prepare for recovery. Applicants are invited to apply for grants of up to £25,000 to address financial difficulties arising from Coronavirus. Grants of up to £50,000 are also available for projects and activities that reduce risks to heritage by providing information, resources and skills. The deadline for applications is midnight on Sunday 3 May 2020 and the funding for successful applications will be awarded from mid-May.

Heritage Alliance (of which the Methodist Church is a member) has produced COVID-19 Guidance for the Heritage Sector. This includes a <u>Covid 19 Guidance</u> Hub and Covid-19 Funding Hub which outlines the advice and sources of national and regional funding to help mitigate the effects of the pandemic.

Charity Commission Annual Returns

Like many organisations, the <u>Charity Commission</u> is coping with increased demand. It has reassured trustees that it will adopt a 'flexible and pragmatic approach,' to regulation in the coming months.

For example, registered Methodist charities can request an extension on submitting their annual returns. The Commission has stated that Serious Incident Reports are to be made as normal, but do not expect a quick reply given the circumstances. Click <u>here</u> to read more.

A Message from Methodist Insurance

Please see below the cover that applies to your church insurance policy.

Church Premises that are Temporarily Closed due to the COVID-19 Outbreak Church buildings that are temporarily closed are exposed to greater risk than buildings that are open for regular use. It is a condition of your policy that you advise us when the use of a building ceases and we would then apply restrictions in cover, which would normally be charged as an additional premium. However, we can confirm that temporary closure of your church buildings due to the COVID-19 outbreak would not result in us applying restrictions in your cover or charging any additional premium. Nevertheless, we do expect that you manage the risks associated with a closed building. Click <u>here for more</u> information.

Churches that engage in Emergency Community Support Programmes

This work is considered to be part of the usual activities of the church. However, we would expect the individual churches to follow Public Health England/Government guidance at all times and observe any stipulated precautions. There would be no additional premium in respect of these activities.
