# Love Your Burial Ground Week

Caring for God's Acre annual [Love Your Burial Ground and Churches Count on Nature](#) week has been set for **8th - 16th June 2024** and there is a focus on the brilliant wildlife to be found in churchyards and chapel yards. It is a joint initiative promoted by Caring for God's Acre, the Church of England, the Church in Wales and A Rocha UK.

Over 27,000 wildlife records have been submitted during this dedicated week over the past two years, and many recorders are continuing to submit records through the burial grounds project on [iNaturalist UK](#).

## Bloomin Beautiful

Churchyards, cemeteries and other types of burial ground are often the oldest enclosed spaces in a parish, town, or city. They host grassland that has remained relatively undisturbed for centuries. The gradual, natural re-seeding over many years has given rise to a diverse ecosystem of grasses, flowers, and animals. This ancient, unimproved grassland, once abundant across the UK, has now become a rarity. We have lost 97 percent of it since the second world war.



Allowing certain areas to grow freely during the summer months enables the flowers to bloom once more. **However, it is important to inform visitors why we are leaving the grass to grow long to prevent any unnecessary concern, so they know that it is active management – not neglect!**

## New Investment to Rejuvenate Rural Community Green Spaces

The Department for Environment, Food and Rural Affairs (DEFRA) has announced a new Community Green Spaces Fund, which will provide up to £7 million in funding to support communities to create, restore and enhance their green spaces. Grants will be awarded through the fund for initiatives such as community orchards, kitchen gardens and natural play areas.



Further funding will support enhancements to village halls through capital investment projects.

## VAT Relief for Charity Energy Upgrades

Buildings used solely for charitable purposes can now save on VAT for installing eligible energy-saving materials like insulation, solar panels, and heat pumps. This tax break went into effect on 1st February.

## **Benefact Trust awards over £400,000 to 12 inspirational project in the latest round of Methodist Grants.**

## **Mission Planning Surgeries**

### **Get Help with Mission Planning**

Perhaps you are not sure how to get started with mission planning. Or you have started working on a plan, but got lost along the way. You may have a plan in place, but you've struggled to put it into action. Or perhaps you need to review your plan so that it fits where you are right now.



The Evangelism and Growth Team, in collaboration with the Learning Network, offer monthly 'mission planning surgeries'. Circuits and churches can book a two-hour slot during which they receive input tailored to their particular context. You could use this time to help you think through a knotty issue, to ask for specific guidance, or to find out about people and resources in your local area who can continue to accompany you in your mission planning. Ideally a few representatives from a circuit or church team would attend together so that the input from the surgery would be shared among the team.

- The full name and address with postcode for the invoice
- The name and telephone number of the contact to arrange access to site

On receipt of this correspondence they will arrange to visit your premises. Subsequent to each annual service carried out, any recommendations for replacement or additional extinguishers will be forwarded to you for your approval.


## Property Stewards' Handbook
