City Centre Churches and Projects

1. Background

In October 2015, the Council adopted the following recommendations [minute 15.3.29]:

- The current Standing Orders should be maintained but the criteria in paragraph 8 [of MC/15/100] should be used to define the features and characteristics of a City Centre Church.
- Churches not meeting the new criteria, following a district review, should be removed from the list and those meeting the criteria should be added.
- Districts should be offered support from the Methodist City Centre Network (MCCN) and the Connexional Team through the Discipleship and Ministries Learning Network (DMLN) to identify and review churches meeting the new criteria (as required by SO 440(5)).
- A new City Centre list should be compiled as part of the connexional database and maintained by the Ministry Development Team from submission from the districts by October 2017.
- The Stationing Committee is encouraged to review the suggestions above.
- Discussion should be held with the Queen's Foundation and MCCN to offer student ministers exposure to City Centre opportunities during initial ministerial training.

The Council further directed the DMLN Ministry Development Team to develop guidelines for City Centre Churches and to work with districts, alongside the MCCN, in reviewing the City Centre List. The Council commended the paper to the Stationing Committee for further consideration, and directed that a new City Centre list be presented to the Council in 2018. This paper contains the revised City Centre List for the Council's approval.

2. How was the list compiled?

A direct approach was made to city centre churches and projects already known (identified using the old connexional list and that of the Methodist City Centre Network). Further information was sent to District Chairs and via the ordained ministers' newsletters. Churches and projects were invited to register onto the new City Centre List by online submission. (For details of the questions asked see Appendix 1.)

In MC/15/100, the Council approved the criteria for inclusion on the City Centre church list, indicatingthat a church or project should have at least 4 out of 5 of the following features:

- The features of the environment are retail, civic, leisure, judicial, commercial and educational institutions serving a dense population.
- The significant population is transient.
- There are obvious extremes of power and powerlessness, wealth and poverty.
- There are obvious changes of community between the daytime and night time economies.
- The City Centre church acts as a magnet to various groups of people.

Each registering church or project identifies as having at least four of the above traits.

5. City Centre Review

Standing Order 440(5) requires each Synod to review the mission and ministry of each church or project on the City Centre List every five years.

Of the thirty five churches or projects listed eleven had some record of a review, often as part of a circuit wide initiative.

In order to help city centre churches and projects carry out their reviews in a timely manner a rota of review is recommended (Appendix 2). The rota takes into account the last known review date and sets the next date 5 years on. It also seeks to integrate the other churches and projects who have not yet carried out a review, grouping regions together to enable a coordinated approach. Churches that have never carried out a review are encouraged to do so before the due date.

6. Guidelines for City Centre Review

Working with the Methodist City Centre Network coordinating group guidelines have been developed using a variety of approaches including: *Our Calling*, Appreciative Inquiry, SOAR and Developing Healthy Churches to enable a review to take place. It is hoped that the variety of approaches will enable a district to best select the review that will help the mission of the church or project. These are available to download from the Methodist Church website.

7. From the Stationing Committee

The Stationing Committee responded by asking who decides whether a church or group meet the criteria. In the first place a church or project self-selects to request to be part of the City Centre List. Standing Order 440 then requires the district synod to decide if it is to be recommended to the Methodist Council via the appropriate member of the Connexional Team, currently the Coordinator for Ministry Development.

8. Further work with the MCCN and the Secretary of the Conference

In 2017 the Secretary of the Conference met with the Revd Dave Martin (the Coordinator of the Methodist City Centre Network) and the Revd Paul Wood (Connexional Team) to consider ways in which the Connexional Team might better support the work.

It was agreed that:

The Coordinator for Ministry Development would work with the coordinating group of MCCN to prepare their conference;

The MCCN website would be migrated to the Methodist Church Website. This can now be found at http://www.methodist.org.uk/mission/the-methodist-city-centre-network

9. Recommendations

The connexional database be amended with the updated list as listed above.

Application to join the list should be made by the website link and administered by the Ministry Development Team reporting to the Council as necessary.

The Ministry Development Team should continue to work with the Methodist City Centre Network.

The purpose of this "getting our house in order" is to place a right emphasis on the potential mission opportunities of City Centre Churches rather than what has sometimes been seen in the past as an avoidance of any sales levy.

Churches and City Centre District Projects are invited to apply to be added to the newly formed list by completing the attached form. Your application will then be referred to the District Policy Committee for their recommendation/approval. Recommendations to the list will then be brought to the Methodist Council for approval. Churches and Districts should note that by being added to the list they commit themselves to a regular review as outlined in SO440 (5).
