Ecumenical Associate Members of the 2017 Conference

1.0 Introduction

- 1.1 In 1989 the Ecumenical Committee proposed that six churches be invited to send representatives to the Conference in any one year. The proposal was adopted by the Conference¹ and ecumenical representatives have been attending the Conference since 1991.
- 1.2 At its meeting in January 2013, the Methodist Council received a report on ecumenical associate members of the Conference and adopted revised principles for inviting churches and Christian bodies to appoint those associate members.

2.0 List of churches and Christian bodies eligible to appoint associate members

2.1 For the purpose of Standing Order 107(1)(i), the following list of ecumenical bodies and associations in Great Britain of which the Methodist Church is a member is used:

Action for Churches Together in Scotland (ACTS)
Churches Together in England (CTE)
Cytûn (Churches Together in Wales)
Free Churches Group (FCG)
Free Church Council of Wales (FCCW)

2.2 In the period since April 2015, when the Council was last updated on this matter, the United Kingdom World Evangelism Trust has become a member of CTE.

3.0 The 2017 Conference

- 3.1 On the basis of the principles agreed by the Council in January 2013, five of the churches and Christian bodies that have appointed associate members of the 2016 Conference are due to do so for the 2017 Conference.
- 3.2 One of the principles was that those churches and Christian bodies other than the Church of England and the United Reformed Church, should be invited to appoint an ecumenical associate member of the Conference normally for two successive years.² 2017 is the 500th anniversary of the Lutheran Reformation and it would be appropriate for the Conference to invite the Council of Lutheran Churches to appoint an associate member of the Conference for that year. Since, however, that Council appointed an associate member for the 2012 and 2013 Conferences, it is proposed that the invitation be for only one year.
- 3.3 In the light of paragraphs 3.1 and 3.2, it is proposed that the Council recommends to the Conference that the following churches and Christian bodies be invited to appoint associate members of the 2017 Conference:

The Church of England
The United Reformed Church
The Catholic Bishops' Conference of England and Wales
The Church of the Nazarene
The Council of Lutheran Churches
The Moravian Church³
