Summary of content

Subject and aims	This report contains the regularly updated list of appointments, authorisations and delegations to clarify the discharge of consents required by Standing Orders and the Model Trusts. This report also reconfirms the delegation to make discretionary payments under Standing Order 365(7) originally granted in October 2020, and the general authority to sign documents on behalf of the Council, originally granted in April 2022.
Main Points	 SO 331(1) provides that the Methodist Council must appoint a Team member to fulfil the duties assigned in the Model Trusts and Standing Orders to the Property Secretary or General Secretary of the Property Division. SO 909 defines 'the appropriate connexional authority' as the Methodist Council or any person(s) to whom it may delegate its powers. This report confirms to whom the Council has delegated its duties and responsibilities as the appropriate connexional authority under SO 909 and who has been appointed as the Team member for the purposes of SO 331(1). This report also: provides for a general delegation in cases of emergency or where the nominated person(s) to whom a particular appointment, authority or delegation has been assigned is/are not available. proposes that the Chair of the Council appoints a group of up to twelve Council members of whom any three can be called upon at any time to consider applications made under Model Trust 20(1) to transfer or grant a lease of Methodist Model Trust property to another charity for Methodist Church purposes at below best price. asks the Council to reconfirm the delegation under SO 365(7) granted by the Council in October 2020 [see MC/20/113 for background] asks the Council to reconfirm the general authority to sign documents granted by the Council in April 2022 [see MC/22/62 for background]

Authorisations and Delegations

- 1 The Model Trusts and Standing Orders contain many references to the responsibilities and duties of the Property Secretary or the General Secretary of the Property Division. However the roles of Property Secretary and General Secretary of the Property Division ceased to exist a number of years ago. Under SO 331(1) the Methodist Council annually appoints a member of the Connexional Team to fulfil the duties assigned to these roles.
- 2 Part 9 of CPD also provides that 'the appropriate connexional authority' will undertake certain duties and responsibilities in respect of property matters. SO 909 defines the appropriate connexional authority as the Methodist Council or any person(s) to whom it may delegate its powers.
- 3 The Council should note that the Trustees for Methodist Church Purposes (TMCP) act on behalf of the Connexional Team in inspecting and approving contracts before they are signed. This has been a long standing arrangement with TMCP, and TMCP are paid from central funds for providing this service to the Connexional Team.
- 4 The Council should also note that, until Special Resolution 42/5 of the 2023 Conference is confirmed (see MC/23/68), even where TMCP approve a contract it is still necessary for the Property Secretary or authorised connexional authority to sign a memorandum of consent under Model Trust 26 before any disposition of Model Trust land can be completed.
- 5 The Council is therefore asked to appoint certain personnel under Standing Order 331 to fulfil the duties assigned in the Model Trusts or in Standing Orders to the Property Secretary or to the General Secretary of the Property Division, and to approve the list of authorisations and delegations which relate to the Council's responsibilities as 'the appropriate connexional authority' under Standing Order 909.
- 6 The Council is also asked to approve a general delegation authorising any one or more of the Secretary of the Conference, the Chair of the Council and the Connexional Secretary to act as the appropriate connexional authority or as the appointed Team member under SO 331(1) in cases of emergency or where the nominated person(s) to whom a particular appointment, authority or delegation has been assigned is/are not available.
- 7 The authorisations and delegations set out in this paper include a requirement that decisions about applications under Model Trust 20(1) (to transfer or grant a lease of Model Trust property to another charity for a purpose of the Church either for no consideration or at less consideration than might otherwise have been obtained) are considered and agreed by three Council members. The Council is therefore asked to authorise the Chair of the Council to appoint a group of between eight and twelve Council members, of whom any three may be called upon at any time to convene and consider applications made under Model Trust 20(1).
- 8 The relevant appointments, authorisations and delegations are detailed within the table below.
- 9 In October 2020 the Council passed Resolution 113/1 to enable discretionary payments to be made on its behalf under Standing Order 365(7) at short notice by the Secretary of the Conference, or the Assistant Secretary in the Secretary's absence. Report MC/20/113 refers. The Council is asked to re-confirm this delegation by passing a resolution in the same form again.
- 10 In April 2022 the Council passed Resolutions 62/1, 62/2 and 62/3 authorising certain members of the Council to sign documents on behalf of the Council in certain circumstances. Report MC/22/62 refers. The Council is asked to re-confirm this delegation by passing a resolution in the same form again.
