Mark Carrick is a presbyter, currently serving in the Derbyshire North East Circuit. He brings experience in recruitment, development and mentoring of staff in senior management. Since becoming a presbyter, he has managed a number of people, undertaken supervision and line management training and journeyed alongside a number of potential candidates. He has a passion for developing disciples and for helping people to discover and use their gifts. He has excellent attention to detail and is good in team situations.

Paula Dawson is a member of Beeston Methodist Church, Nottingham, Paula believes strongly that ordained clergy play a key role in building God's kingdom in local communities. She is a registered nurse and has experience in a range of professional roles including recruitment and selection.
