How vegetable oil heated a Cornish village

A Methodist Church in a Cornish village has been part of a trial using vegetable oil as fuel. The church converted its relatively new boiler at minimal cost and now has a much more responsive and cost-effective heating system.



The district's environment advocate Andrew Geake says: *"This renewable fuel can do the same job as existing heating oil whilst saving nearly 90 per cent CO2 emissions. So in one easy step, this brings this Church very close to achieving the Net Zero target."*

Renting manses to refugees

Since 2016 the [York Circuit](#) has been using manses that were not currently needed for ministers to house refugee families. Two manses are currently occupied by families who arrived in the UK under government schemes designed to

This project initially grew out of the Circuit's response to the war in Syria and the 'Refugees Welcome' campaign which encouraged churches to consider what they could do to show God's caring love to those seeking safety from conflict and hardship.

Vandalism Threat to Heritage Sites Amid cost of Living Crisis

A new report from Historic England and the National Police Chiefs' Council reveals a worrying increase in theft, vandalism and antisocial behaviour at the nation's historic sites. Incidents – like graffiti, or the theft of York stone – expected to continue rising due to inflation's impact on commodity prices. The report urges better police recording of heritage crimes to grasp the full scale of the problem. [Click here to read the report](#)



Additionally, research commissioned by Ecclesiastical Insurance reveals UK heritage organisations suffered a rise in graffiti, anti-social behaviour, and verbal abuse last year. Crime is a top concern for heritage organisations: six in ten (57%) are expecting an increase over the next year, and seven in ten (69%) are more concerned than ever before. New Research shows that Heritage boosts your well-being

The analysis demonstrates that Grade II listed buildings, which represent 92% of England's historic places on the National Heritage List for England, are the main drivers of life satisfaction increases. This suggests that it is proximity to a wealth of everyday local heritage – rather than the presence of rare, exceptional historic places – that is responsible for driving a higher life satisfaction. Your home insurance in the current climate

According to the ABI, home insurance claims for weather-related damage reached a [record £573 million in 2023](#). Though these claims were mostly due to the succession of storms including Babet, Ciaran and Debi, the ABI also reported a rise in the cost of accidental damage, theft and water leak claims associated with the cost of living crisis.

Some general maintenance can help to protect buildings from damage and spring is a good time to carry out some checks and repairs. It's also important to check your sums insured are adequate to cover the cost of replacement items should you need to claim.

HSE Update

Asbestos and You campaign

HSE's Asbestos and You campaign urges tradespeople to stay aware of hidden asbestos and protect themselves and others from exposure to asbestos fibres during their work.



Every tradesperson is likely to carry out work in a building that contains asbestos at some point. Those doing repairs or refurbishment are at a higher risk of disturbing asbestos, especially when working in houses built before the year 2000.

Make sure you are working safely at height

Falls from height continue to be the most common cause of fatal accidents to workers. [HSE's statistics](#) show that falls from height were the main cause of

worker fatalities in 2022/23, with 40 workers killed. Between 13 and 17 May, the No Falls Foundation is launching its first ever [No Falls Week](#), a campaign dedicated to promoting safe working at height.

Mission Planning Surgeries

Get Help with Mission Planning

Perhaps you are not sure how to get started with mission planning. Or you have started working on a plan, but got lost along the way. You may have a plan in place, but you've struggled to put it into action. Or perhaps you need to review your plan so that it fits where you are right now.



The Evangelism and Growth Team, in collaboration with the Learning Network, offer monthly 'mission planning surgeries'. Circuits and churches can book a two-hour slot during which they receive input tailored to their particular context. You could use this time to help you think through a knotty issue, to ask for specific guidance, or to find out about people and resources in your local area who can continue to accompany you in your mission planning. Ideally a few representatives from a circuit or church team would attend together so that the input from the surgery would be shared among the team.

If the following details could be provided to enable them to add your premises to the Churches contract:

- The full name and address with postcode for the invoice
- The name and telephone number of the contact to arrange access to site
- The name and address of the site that is to be serviced
- The due month in which the service is required

On receipt of this correspondence they will arrange to visit your premises. Subsequent to each annual service carried out, any recommendations for replacement or additional extinguishers will be forwarded to you for your approval.


Property Stewards' Handbook
