- 1 The 2022 Conference agreed a reduction in the size of the Methodist Conference from 306 representatives to 225 (in addition to a small reduction in the numbers of associate members). This change comes into effect at the Conference of 2024. It also agreed that the proportion of Synod representatives be no less than 70% of the membership, the remainder being made up of various exofficio groups.
- Within the conversation at the Conference there was a general acceptance that the overall size of the Conference needed to be smaller, to reflect the size of our Church today and to pay attention to the costs both carbon and financial of holding such a large scale event. What was less clear was how the Conference wished to reduce the number of ex-officio representatives and members representing various groups were generally reluctant that their group be reduced in number or removed. The work to clarify the make-up of the ex-officio representatives to the Conference was referred to the Methodist Council to work on, in collaboration with the JDS Committee (which is represented on the Council). This paper offers a way for that work to begin.
- 3 The Conference chose not to agree at this time to changes in the number and arrangement of Districts, having a concomitant effect on the number of Chairs, which is the largest ex-officio group. Further, the Conference also decided to move to replace the Methodist Council and the Strategy and Resources Committee with a Connexional Council, and the expectation is that the members of the Connexional Council will also be representatives to the Conference.

## Next Steps

4 It is clear that in order to retain the desired proportion of Synod representatives, there will need to be significant changes to the ex-officio representation. The second column below uses the reductions recommended to the 2022 Conference, with the fixed points of the number of District Chairs and members of the Connexional Council added in.
