## Connexional Grants Committee Annual Report for year ended 31 August 2020

#### 1.0 Introduction

- 1.1 The Connexional Grants Committee (CGC) including its sub-committees and subsidiary streams is appointed annually by the Council in accordance with Standing Order 213B to manage the grant making process. This report includes summary overviews of Mission and Ministry in Britain and World Church grants budgets, applications received and grants awarded in the connexional year 2019/20.
- 1.2 From a budget of £2.36 million for Mission and Ministry in Britain grants, £730,274 has been awarded because grant-giving was suspended before the spring grant allocations, including the annual amount set aside for property grants, could be awarded because of the coronavirus pandemic
- 1.3 From a budget of £4.08 million for World Mission grants, £3.79 million has been awarded. The budget was increased by £650,000 to enable COVID grants to be given to all partner churches, if needed.
- 1.4 The CGC has continued to work closely with the connexional Finance team and auditors to refine and document payment processes and introduce additional rigour in grant-making controls.
- 1.5 The Mission and Ministry in Britain budget for 2020/21 approved by the Conference is **£nil**, due to the suspension of grant-giving as part of the review of all connexional expenditure as a response to loss of income due to the coronavirus.
- 1.6 The World Mission grants budget for 2020/21 is £2.15 million.

## 2.0 Grants budgets 2019/20

2.1 **Mission and Ministry in Britain** – the budget agreed by the 2019 Methodist Conference was **£2.36 million**. The following table show the annual grants budgets, by fund, over a three-year period.

## 3.0 Mission and Ministry in Britain, including Fund for Property

Tables 3 and 4 below show the number and value of grant applications received and awarded in 2019/20 and 2018/19 (NB – grants awarded from the CPF include both property and non-property projects.) Appendix 1 provides a breakdown of grant awards by District. 75 applications were received during 2019/20 (121 in 2018/19).

- 3.1 **Mission in Britain Fund** One grant of £100,000 or more was awarded during 2019/20 (four in 2018/19); this was £110,435 to Bastion Tabletop Gaming Ministry.
- 3.2 **Property Grants** 22 applications totalling £2,161,000 were received but no grants were awarded.
- 3.3 **Grant allocation policy** The CGC continued to award grants based on the evidence given in individual applications and an assessment of how they fulfil the grant criteria.

3.4 **Methodist Action on Poverty and Justice (MAPJ)** Six MAPJ grants were awarded totalling £265,000, no Christians Against Poverty (CAP) debt centres were funded; this compares with 26 grants, including five CAP debt centres or job clubs, totalling £800,000 in 2018/19).

#### 4.0 Changes to Ministry and Mission in Britain grants during 2019/20

- 4.1 A review of connexional grant-giving was carried out during the year. Future grant-giving will be driven by God For All: The Connexional strategy for evangelism and growth. Under God For All applications for connexional funding will be jointly developed by districts and Evangelism and Growth staff. The current application process has therefore come to an end. Legacy work (ongoing payments of committed grants and monitoring processes) will continue and grants staff will be reorganised within the Connexional Team.
- 4.2 No property grants were awarded during the year. It was originally intended to have one round of property grants but this was impacted by the decision to suspend grant-giving in the spring.

#### 5.0 World Mission Fund grants

5.1 The tables below show the value of grant applications received and awarded, by grant type, in 2019/20 and 2018/19. Grants from the World Mission Fund support the training of students from partner churches (SALT), the post of a national of the partner church to do strategic mission work for the Church (NMA), the general functioning of the Church or partner organisation (Annual), and respond to unexpected need such as disaster relief, purchasing medical equipment, etc (General).

5.2 Work has begun on reimagining Global grants, in parallel with the changed approach for British grants. A survey of partner churches is currently taking place which seeks their response to questions aimed at working more closely in partnership and avoiding colonial approaches to awarding funding.

### 6.0 MELD (Monitoring, Evaluation, Learning, Dissemination)

6.1 The World MELD group is currently reviewing selected SALT grants to determine whether those who have received training (largely Masters and PhD programmes) have continued in leadership and

- theological education roles in their churches. This work is being carried out in partnership with Cognitive Edge who have designed an innovative online survey to capture qualitative answers.
- 6.2 The British MELD group have continued to highlight learning that can be shared throughout the Connexion. Grants staff have worked closely with the One Mission Engagement Officer (this position has now been made redundant) and the Media team to share and develop good news stories.

#### 7.0 Grants Policy

7.1 The CGC's policy setting out the limits for reclaiming property grants and a revised Standing Order (SO 916) was agreed by the 2020 Conference.
