## Delegation of oversight of the Auxiliary Special Purposes Fund to the Connexional Allowances Committee

- 1. The Methodist Council is the managing trustee body of the Auxiliary Special Purposes Fund, which is administered alongside other connexional funds by the Connexional Team Finance Office. It is a restricted fund with an unaudited balance as at 31 August 2017 of £557k. Its income is derived from investments, which generally speaking provides sufficient cover from year-to-year to meet the demands upon it. The annual unaudited expenditure in 2016/17 was just under £35k.
- 2. The fund provides financial assistance when marriages or civil partnerships involving ministers have broken down. It is particularly used when a spouse/partner and/or children have to leave the manse and become temporarily homeless as a result.
- 3. Because of the rare and sensitive nature of such cases, the fund has been overseen informally by the Secretary or Assistant Secretary of the Conference; generally used after advice from a person appointed by the current President to offer support in such cases and the Chair of the Connexional Allowances Committee (CAC).
- 4. There are overlaps between the use of this fund and the Fund for the Support of Presbyters and Deacons (FSPD) and the work in general of the CAC, much of which is sensitive and confidential. It is therefore proposed that with immediate effect oversight of this fund is delegated to the CAC, this will not however effect the ability of the Secretary of the Conference to use the fund for the purposes of as set out in paragraph 2 above.
