## **World Church Grants Stream Structures**

The April 2015 Council approved modifications to the world church stream structures for a trial basis in 2015/16. This occurred as a result of the work regarding the making of grants to world church partners within the overall strategy for overseas partnerships. The CGC considered changes to the Stream structure in order to facilitate more joined up thinking between grant programmes.

The Committee asked the Council to agree that the stream structure may be modified during the year on a trial basis, with an alternative structure recommended to the Council in April 2016. It now requests that the Council allows the CGC to act experimentally for another year, 2016/17, in the way it organises the streams for mission and ministry in world church grants. At its meeting in January the Council agreed to the formation of the new Global Relationships Strategic Oversight Sub-Committee (GRSOS). This further year of experimental working will allow the CGC and GRSOS to work together towards developing a structure that will enable the CGC to fulfil its role in grant-making in support of the new policy relating to global relationships.

The Committee will bring alternative structure recommendations to the Council in April 2017.
