Resolutions	61/1. The Council adopts the proposals in the report for establishing the One Mission Forum in accordance with Standing Order 1001.						
	61/2. The Council delegates to the Strategy and Resources Committee its authority to make additional appointments to the Forum under Standing Order 1001(2)(a)(iv).						

- 1. The One Mission Forum will have the following responsibilities [as set out in Standing Order 1001(1)]:
 - (i) to develop and support a network of people committed to mission both local and global;
 - (ii) to challenge the Church to learn from and keep constantly under review its place within the world Church;
 - (iii) to share insights and develop vision;
 - (iv) to confer about how the vision and policies for mission adopted by the Conference might be implemented in the Church.
- 2. The Forum's membership is to be constituted mainly of representatives from the districts [as Standing Order 1001(2)(a) indicates]. Above all, these representatives will need to have a passion for mission and the wholeness of mission, and a commitment and ability to explore ways of improving communications to and from their own district and its constituent circuits and local churches. It seems more important to achieve this quality of representation than to have a balance on the Forum between lay and ordained.
- 3. The Standing Order stipulates that the representatives from the districts are elected by their district synods. In order to ensure that there is a proper continuity between the previous World Mission Forum and the new One Mission Forum, we propose that a number of districts be invited to elect to the One Mission Forum a person who has previously represented them on the World Mission Forum but who also has an understanding of and passion for the oneness of mission. In order to ensure that other aspects of mission are also properly represented on the new One Mission Forum, we propose that the remaining districts be invited to elect someone who has particular interests in "Fresh Ways of Being Church" or "Evangelism" or "Public Issues and Community Action" (these being the categories pointed to in the 2014 report to the Conference), but who also has an understanding of and passion for the oneness of mission.
- 4. To enable the new One Mission Forum to become properly established, we propose that some of those being elected be for a period of 4 years, some for 5, and some for 6.
- 5. Please see the table below for the way in which these proposals work out in practice.
- 6. We also propose that the districts be asked to indicate the particular interests and experience of those they elect as representatives. This will enable additional appointments to be made to

the One Mission Forum under Standing Order 1001(2)(a)(4) to ensure that all aspects of mission are fully represented. In order for this work to be done properly, we propose that the Council delegates the authority to make these additional appointments to the Strategy and Resources Committee.
