

Every day more than 50 children are taken into care in the UK.

They are removed from chaotic, traumatic, abusive, neglectful or desperate situations. Some will need a home for a few nights, some for a few months or years, while others will not be able to return to their birth families and will become one of the 4,000 children who are currently waiting for a permanent home with a new forever family.

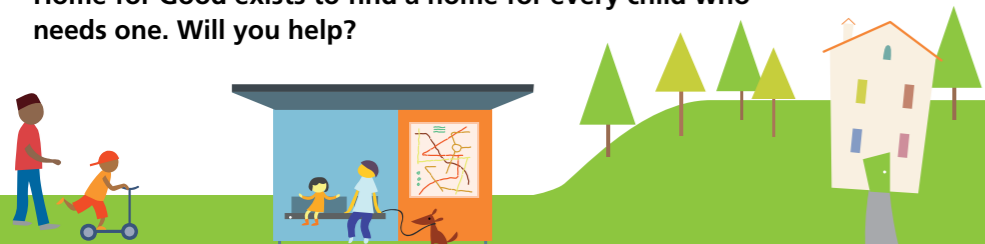
We believe the Church is ideally placed to help meet this need – both in terms of finding families to foster or adopt and providing an excellent community of support to wrap around those who do.

Home for Good is a charity that aims to make adoption and fostering a significant part of the life and ministry of the Church in the UK. We raise awareness of the need for foster and adoptive parents, encourage families to provide loving homes for the children in care, and equip the Church to be a welcoming community for them.

Being part of the solution to this need isn't just wishful thinking. Through our connections, Home for Good has a voice into approximately 15,000 churches. If one family in each of these churches chose to foster or adopt, there would be no children in the UK without a home.

We believe this is a fantastic opportunity for the Church to be good news in society, to change our communities, and to transform the lives of some of our country's most vulnerable children.

9,000 young people leave care every year – what happens to them?

- 22% of female care leavers become teenage parents
- 24% of the adult prison population are care leavers
- A third of homeless people have been in care
- At least a third of sex workers, and potentially as many as 70%, have been in care
- 38% of care leavers are not in education, training or employment (NEET)

It's great that the Church in the UK is increasingly working to support the adults who face these problems, but let's not wait until that point – let's get involved with the children as they come in to care and need a home for good.

1. Sign-up

By signing up to be a Home for Good church you are joining a national movement of UK churches that are passionate about their call to care for vulnerable children. 2. Pray

As a church, commit to praying regularly for children in care, foster carers, kinship carers and adoptive families – and for the work of Home for Good.

3. Give

Consider how your church can financially support the work of Home for Good.

- Take up a special offering for the work of Home for Good – perhaps on Adoption Sunday or at Christmas
- Make Home for Good your ‘charity of the year’
- Engage your congregation by fundraising for Home for Good
- Give regularly as part of your church’s mission giving

Welcome and Wrap Around Families

Take these practical steps to ensure that looked after children, foster carers, kinship carers and adoptive families feel safe, welcome and supported in your church.

1. Welcome

Use inclusive language. When you make announcements or write a church notice deliberately say ‘parents and carers’ as this small change can make a whole group of people feel welcomed and included. Your children’s and youth leaders could also attend a Home for Good training day to help them better understand the needs of looked after children and their families, and find out what they can do to ensure that children and youth activities are inclusive.

“When we were preparing to adopt our daughter ten years ago our church family walked through the ups and downs with us just as they would have done had I been pregnant. A few weeks after she arrived and we “hit the wall” and were exhausted, they arranged a meal rota for a couple of weeks just as they would have done had I given birth.” **Ruth, Sheffield**

2. Help

Take time to ask the foster carers and adoptive parents in your church what support they need. Encourage small groups to facilitate intentional practical support for things like cooking and laundry, and where appropriate, offer help with babysitting or school runs.

3. Connect

Facilitate opportunities for foster carers, kinship carers and adoptive parents to connect with one another. Home for Good can provide guidelines on how to set up and run informal support groups.

St Peter’s Church in Bolton host a bi-monthly Saturday lunchtime support group for foster and adoptive families, and more than 40 adults and children attend.

Sutton Vineyard, have compiled a list of skilled people in the church who could help those in the assessment process with home improvement, or could offer reduced rates for things like boiler checks or help with accountancy.

Be Part of the Solution



Raise awareness in your church, dispel the myths, and encourage individuals and families to consider fostering or adoption.

1. Profile

Profile the issues facing children in our communities and the need for more foster carers and adoptive families during your Sunday services. Home for Good produces resources that can be used – particularly on Adoption Sunday, Mother’s Day and Father’s Day.

2. Inform

Fostering and adoption isn’t for everyone, but some people haven’t even considered it because of misconceptions. Make sure people have access to information about fostering and adoption. Display Home for Good information leaflets and posters and make sure people know that you’re a Home for Good church. You might also like to consider hosting an information evening for people who want to find out more.

“Since our Adoption Sunday service, three more families have been approved as foster carers or adopters – taking the total to five. It’s a great opportunity to encourage people who may have been considering it to find out more – in a place where they can have their questions answered in a safe and secure environment. If the Church won’t step up, who will?” **Andy, Yeovil Family Church**

3. Celebrate

As Christians, we have all been adopted into God’s family – this is something that we should celebrate. Make sure adoption is a regular feature in your worship and teaching.
